Community Council Meeting
September 15, 2015

Welcome by Gary Gibb-introduce council members. Jimmer Standring and Rachel Baldwin are newly elected parent council members. Amberlie Benson is new employee member. Tami Galbraith will replace Portia Ames vacated employee seat for one year.

Council Training Responsibilities of the Community Council. The State Legislature insures that every school has a Community Council where parent involvement supports school programs, determines schools greatest needs, and how Trustlands funds are used to benefit the school. The Council determines safe walking routes and is now responsible to approve a digital citizenship plan at the school.

Training for Council members: State provides training at Centennial Middle School November 12, 6-8 p.m. District training will be held Monday, September 22. Lucie Holman will be attending that training with Mr. Gibb.

Responsibilities of the Chair is the prepare agenda, conduct meetings, assure minutes are kept, yearly time-line of meetings, make sure patrons are aware the meeting is open to the public, use the bi-laws for the council. Specific responsibilities are defined online at www.schoollandtrust.org.

Elections for Chairperson and Co-Chairperson. Nominations opened for Chairperson-Jimmer Standring was nominated by Rachel Baldwin. It was seconded by Lucie Holman. After discussion voting was unanimous. Nominations for Co-Chairperson-Rachel Baldwin was nominated by Gary Gibb and seconded by Jimmer Standring after discussion the vote was unanimous.

Proposed meeting schedule. Consensus of the group was for meetings will be held on Wednesday mornings at 7 a.m. The next meeting will be October 14. A draft of the schedule was approved and will be made available on Legacy's website. The agenda for the next meeting will include the School Trustlands grant for 2015-16 and a report of the grant from 2014-15. Final report is due online by Oct. 20.

Trustlands Review: Funding was increased for 2015-16 by 17% over projections. Legacy will have \$52,637 plus any carryover from last year. Funds will be spent according to the grant proposal approved in April 2015.

Data review. Legislative Report Cards and Utah's PACE report card will be publically released today. They can be accessed at datagateway.schools.utah.gov
Legacy is doing very well and received an A grade. Legacy scored 430 points on the PACE.

Safe Walking Routes. The crosswalk at 1340 N Center St. has become eligible for a school zone and crossing guard. American Fork City has hired a new crossing guard for the crosswalk. As soon as signs are in place, she will begin working. The Council reviewed a draft of proposed changes to the safe route, based on adding a crossing guard. Most notable change was the recommendation that students east of Center Street and North of 1340 N travel to the crosswalk at Center to cross. This will mean some extra

distance for some. Jimmer Standing motioned that the draft be accepted, Rachel Baldwin seconded. The council discussed evaluating this new change once the crossing guard is in place. The vote was unanimous. The SNAP plan will be posted on the school website and sent home by email. Mr. Gibb will send it this week.
